Landlords are responsible for returning security deposits, usually within 15-45 days of the move-out date, but this varies by jurisdiction, so be sure to know yours. Probably the most important term is the implied term, under section 11 of the Landlord and Tenant Act 1985, that landlords of most tenancies must keep the structure and exterior of the dwelling-house in repair, and keep the installations in the dwelling-house for the supply of water, gas, electricity, sanitation, space heating and heating water in good repair and proper working order.
