Integrity – Ethics for Tax Administrations

The ethics of tax apply to both, but are exacerbated by the fact that a taxpayer may owe tax (sometimes on the same source of income, gain, asset or cash flow) to different tax authorities, both of whom may lay claim to that taxing right. It is therefore obvious that decision making processes are required for both.
